## EARLY YEARS PUPIL PREMIUM APPLICATION FORM

CHILDREN WHOSE PARENTS/CARERS RECEIVE ONE OF THE FOLLOWING BENEFITS WILL GENERATE EARLY YEARS PUPIL PREMIUM FOR THEIR SETTING/SCHOOL:

- ✓ **Income Support (IS)**
  - ✓ **Income-based** (not contribution-based) **Job Seeker's Allowance (IBJSA)**
  - ✓ The **Guarantee** element of the State Pension Credit.
  - ✓ **Income-related employment and support allowance** or
  - ✓ Financially supported by NASS (National Asylum Support Service).
  - ✓ **Child Tax Credit** except if you meet ANY of the following criteria -
    - i) entitled to working tax credit (regardless of income)
    - ii) have an annual income in excess of £16,190 (Please note that this figure is for April 2014 and that it can change each year).
- Where a parent is entitled to Working Tax Credit during the four-week period immediately after their employment ceases, or after they start to work less than 16 hours per week, their children are entitled to early years pupil premium.

Administration for the early years pupil premium is undertaken by Buckinghamshire County Council for those pupils attending an education establishment within Buckinghamshire. **This form should be completed and returned to your child's setting/school.**
